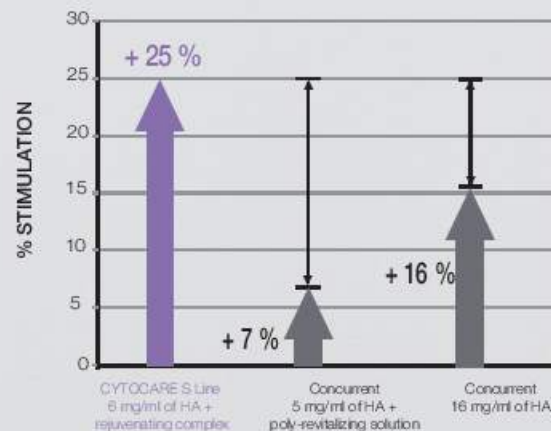

## TECHNIQUES

- Fan injection
- Cross-hatching
- Retrotracing
- Point-by-point

## PROTOCOL

- Injection into the medium or superficial dermis.
- Treatment areas: face, neck and back of the hands.
- 30G needles supplied with CYTOCARE S Line.
- Protocol: - 1 session to fill fine lines & improve skin lightening effect.  
- For long-lasting result, 3 sessions with 3 weeks intervals for intense skin revitalization.

The practitioner decides on touch-up treatment depending on the maturity of the skin.


## CHARACTERISTICS

- Box: 1 x 3 ml syringe + 2 x 30G needles
- Sterilization: aseptic filtration
- Ready to use
- Conservation condition: 2°C to 30°C
- Pyrogen free
- Close to neutral pH
- Iso-osmolar solution

CYTOCARE S Line is a medical device class III (CE 0499) manufactured by REVITACARE SARL, indicated for the prevention and attenuation of wrinkles and fine lines, for the hydration of the epidermis of face, neck and back of the hands, and particularly recommended for the rejuvenation of sensitive areas such as peri-oral and peri-orbital areas. For medical use. Read carefully CYTOCARE S Line leaflet before using the product.

CYTOCARE S Line must be injected in an aseptic manner, by duly practitioner, with sterile and single use equipment supplied by REVITACARE SARL. Before use the product, check the expiry date on the syringe labelling, the integrity of the primary packaging for the syringe and needles and the appearance of the solution. Store between 2°C and 30°C, away from the light in its original secondary packaging. Do not use if package is damaged. Once the CYTOCARE S Line syringe is open, use it immediately. Discard the syringe, needles and the remaining product after use, in accordance with the procedures in force in the establishment. Single use solution: do not re-sterilize and do not re-use. Risks linked to the re-use of the device are infection, inflammation, oedema, cross-contamination, pyrogenicity. CYTOCARE S Line is a medical device class III non-refundable. The practitioner must inform the patient that there are potential adverse effects linked to the injection of our device such as pain, tingling, redness, slight local inflammation, oedema and small haematomas.
